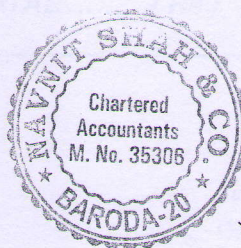


Name of The Public Trust : **STATE BODY BUILDING ASSOCIATION - BHAVNAGAR.**

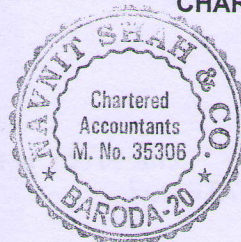

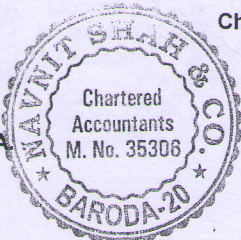
