 Office: : The Registered Office of the Association shall be within Gujarat State.
 Address : Olympia Gym. Manekwadi Balkridangan, B/h. Shiv Shakti Hall,
 Crescent, Bhavnagar-364 001.
 Jurisdiction : The jurisdiction of the Association shall be whole state of Gujarat
 and shall be extended to all such areas included from time to time.

Aims & Objectives:


1. To impart instructions and training in Body building to Players and to hold coaching class and/or camps for them.
2. To propagate ideas on the development of health, physical cultural and personal physique.
3. To organize and conduct coaching and training classes and/or camps for officials and to hold examinations.
4. To organize and conduct inter dist., Regional, State, Inter-state, National and International level Body building contest or championship.
5. To authorize holding of the local, inter-district invitational and exhibit-ional contest in the State.
6. To act as the controlling & governing body of the game within the state of Gujarat.
7. To select the teams to represent the State and to arrange for their training.
8. To affiliate district Associations promoting and organizing Body Building contest and/or championship in the state, to exercise control over the game through such affiliated Units and help them whenever necessary.
9. To co-operate with the Gujarat State Sports Council and with any other Sports Body which the State of Gujarat may appoint from time to time.
10. To provide funds for :
 - (a) the payment of affiliation fees
 - (b) the expenses of the Association.
 - (c) Holding the competition or championship from time to time.


- (d) Publishing literature (instructions & pamphlets, rules books etc. on Body Building and to sale and distribute the same for teaching or for the encouragement and popularization of the Game.)
- (e) the expenses of sending Representatives and teams to participate in Body building tournaments or championship, nationals etc. within or outside the jurisdiction of the Association.
- (f) Employing coaches, Technical advisors, choreographers, secretaries, clerks, service staff etc., if and when necessary.
11. To collect funds for the Association and to utilize them for the fulfillment of the aims and objectives of the Association as may decided by the Executive Committee from time to time.
12. To invest the funds of the Association, not immediately required, in a manner authorized by law and as determined by the Executive Committee.
13. To arrange and hold conferences, demonstrations, exhibitions, meetings, lectures, discussions and generally to do all acts and think necessary to promote the health of the community and to encourage healthy living.
14. To maintain a Library of books and Video cassettes on the game of Body Building helpful to reach the game and develop the spirit of sportsmanship.
15. To accept donations, trophies, cups or shields, gift articles etc. for the state or other body building contest or championship.
16. To receive any gift for any one or more of the objects of the Association as may be approved by the Executive committee from time to time.
17. To establish among other things, a trust for the welfare of the Body buildings, and members of the Association and to appointment trustees for such a Trust.
18. To co-ordinate the activities of the Game of the Body Building and to appoint sub-committee in order to achieve above object.
19. To frame rules and regulations for conducting competitions in the State and to interpret and to implement such rules and regulations.
20. To promote the physical, moral, social and cultural welfare of the member and to do all such things are incidental or conductive to the attainment of the above objects or any of them.
21. To affiliate to the Indian Body Building Federation and to take all steps and to do all acts and things as may be necessary to continue such affiliation.



22.If upon winding up or dissolution of the Association there shall be remain after satisfaction of the all debts and liabilities, any property whatsoever, all the same shall not be paid to or distributed among affiliated Health Club, Associations or Members but shall be given or transferred to some other institutions having objects similar to this Association as determined the members of this Associations, at or before the time of dissolution and default thereof by such judges of the High court as may have or acquire jurisdiction in the matter and if so far as affect can not be given to the aforesaid provisions then to some Charitable Objects.

23.The Association shall be registered under registration of Society Act XXI of 1860. We the several person's names and addresses are subscribed hereunto desires of being formed into a Society in pursuance of this Memorandum of Association under the Society act.


